

Chapter 12 Designing Homeopathic Remedies

There are no overarching principles of how to design homeopathy as a system, only principles that have been established and confirmed by repeated experience.

Hahnemann did not contemplate homeopathy at this level. He did not define the meta-Jevel principles of homeopathy. He did not state a more fundamental principle than *like cures like*. In healing it looks to me like there is not one, since many holistic therapies work 'individually'. I showed earlier that *like cures like* is the probable basis of traditional healing with roots that go back hundreds of millions of years

I can argue that *like cures like* is an aspect or a subset of a higher order principle. Hahnemann did not define from which *like cures like* comes. I tentatively suggest that *like cures like* is a subset of love. That *love creates*, has *affinities*, *resolves* etc can be understood as fundamental dynamics of love. I suggest in particular that the principle that *like creates like* is a subset of love dynamics, just as *like cures like* is.

Concerning remedy sources

It would be a mistake to assume that Hahnemann ruled out other types of remedies than minerals, metals, plants, animals and human sources. Hahnemann did not rule out designer remedies. I am almost sure the thought never occurred to him to include them.

Hahnemann did not have so many options to consider as remedies; if he had, he could have included them as possibilities in Aphorism 105, which he limits only to natural remedies, as designer remedies were not then an option. However, he used magnetic remedies, so he was clearly open to the idea of non-physical remedies, the imponderables, and more than those from just minerals, metals, plants, animals and human sources. He was mightily fascinated by magnetic remedies and he proved and used three magnetic remedies; to quote from 'Synoptic Materia Medica' by Frans Vermeulen, Hahnemann stated: 'the south pole seems to excite the flow of blood, ... the north pole seems to do the reverse'. There is no doubt in my mind that he would have experimented further, had the technology been there at the time. He did not conclude that only natural substances can be remedies, and Organon Aphorism 105 outlines the fundamental CEED criteria, that the remedy must cover the totality of the disease. He certainly did not solve the problem of finding remedies that could do this.

About diseases

Diseases are not such complex phenomena; they just appear to be, from the struggles we humans experience in dealing with them. It is not the disease that is complex, but our understanding that gets lost in our human-made micro-sighted complexities.

Actually, I have come to the conclusion that anyone who makes something very complex to explain, does not fully understand what they are talking about. It is routine in microminded science for things to be explained in very complex terms initially, as scientists struggle to understand and explain the new reality. With time this naturally simplifies.

Once you get to really focusing on diseases you can see they are really primitive and simple things. Traditional African healers understand these things and act accordingly. For example they draw lines in the sand to indicate that this is not the way to go, or to stop a process. It is only our convoluted western minds, containing too many small, isolated and partial facts, and full of scepticism and taboos, and having too little understanding in consequence, that struggle so much with simplicity. Simplicity is the nature of all things.

Edward De Bono, one of our greatest living thinkers, wrote a whole book called 'Simplicity'.

Designing Homeopathic Remedies

In my opinion, education, medicine and science in particular have lost the plot in this regard and have strangled themselves in complexity. Reading a medical manual of diseases makes me feel like I am reading the descriptions of blind men groping in the dark and describing what they feel of reality in visual terms. It seems like an Alice in Wonderland world, the way it is described. And so often, 'we don't know' expressions are included in the official names and descriptions of diseases.

Treating a disease totality is then the process of creating an energy that mirrors back the total effect of the disease on humanity. It is in effect giving a bit more intelligence to the immune system, which is a lot more than just T-lymphocyte cells in the blood. It is like giving it a software update to fix a recently discovered problem, like a new e-mail virus fix.

I call the high-level immunity the macro-immune system and the virus/T-cell level immunity the micro-immunity. Homeopathy primarily addresses the macro-immunity, the realm of will power, information, love, soul, and trauma whereas medicine fights viruses so that the hopefully undamaged micro-immunity can finish the job.

My concept of designer remedies is basically a *loving*, *healing thought form*, aimed at the totality of the epidemic disease or the remedy pattern, which can be impregnated into water by a variety of means. It acts upon the macro-immunity. I have outlined a magnetic method to create the final product.

Concerning electromagnetic remedies

There is a long history of using electromagnetic forces in healing.

Actually everything is electromagnetic in nature: plants, mineral, metals, gases - everything.

Healing is also guided by divine loving energy, which operates at a deeper level than electromagnetism, which is more like the effects in our physical realm.

There are existing homeopathic remedies, made from bar magnets by Hahnemann himself, with lots of listed cases over two hundred years as to their healing effects.


It is common practice on the cutting edge of treating disease today to zap parasites using a fixed frequency electrical zapper. This is still fighting the opponent - something I do not believe ever has a long-term future. It is not the way of the healer, but of disease mechanics. It is not wrong. It's just a lower order of healing through attacking effects. It does not touch causes, but just deals with effects.

Electromagnetic warfare was conducted by the Russians, specifically targeting and destroying the health of the US ambassador in Moscow.

Electromagnetic warfare on AIDS is currently under development in Durban, South Africa. That these work superficially, I do not doubt, but I know that they are not a good idea.

My point is that, if electromagnetics can be used to zap and fight disease, so can electromagnetics be used to mobilise the immune system and strengthen its powers to bear upon a virus.

In actuality the electromagnetic load impinging on us right now has become a serious disease risk. There are TV and radio signals, electromagnetic fields from our electric mains, microwaves in and around our kitchens, radiation from our mobile/cell into our brains, radiating doorbells, and numerous other radiations affecting our health permanently. It is not like you can walk away from it. People who work or live near radar get bigger doses, so do electric power workers, fast/junk food workers etc, and these exposures have been proven to be
