

INTRODUCTION

This book is the first one showing results of systematical verification of homeopathic symptoms in daily practice.

It is not a simple expert opinion but shows facts and results obtained by using homeopathic medicines in first line practice after systematic and statistical analysis of all prescriptions made during 16 consecutive years.

After the description of the method analysis, the first part of the book gathers the homeopathic medicinal remedies allowing to formally predict a positive result when administrated to patients showing several associated symptoms. For these remedies, not only the symptoms but also the **globality law** are verified.

The second part of the book gathers the homeopathic medicinal products for which several symptoms are verified; but considering the restricted number of patients who were given one of those remedies, we only verify the link existing between each of these symptoms and the obtained medicinal effect.

Finally, the third part of the book presents the homeopathic medicinal products for which only one symptom can be verified linked to the efficiency of the medicine. So it concerns remedies prescribed only to a few patients.

In order to ease further studies, we indicate also the symptom verification values which could not yet be proved but which could be verified in the future, using a larger panel of patients.

During the work, we noticed that for some homeopathic medicinal products, it occurs that a link exists between the efficiency of the remedy and one diagnosis. This link is not as strong as the one existing between the patient's symptoms and those of the "remedy" (similarity law). But in some cases, it is to be remembered.

Medicine wants to be more and more based on evidence: 'Evidence Based Medicine'. The evidence-level got by this study, for some homeopathic remedies, is a level IIIb of EBM; that means the higher level that can be obtained by this kind of analysis. This is the same level of evidence than the one that obtained for the evaluation of diagnostic methods, psychoanalysis or surgery. In these cases, the double-blind method is not applicable (level II and level I).
